THIS STATEMENT is made the 13TH day of JULY One thousand nine hundred and eighty-seven by SUFFOLK COUNTY COUNCIL ("the County Council")

WHEREAS:

- (1) The County Council is the Surveying Authority for the County of Suffolk for the purposes of the Wildlife and Countryside Act 1981
- (2) The Definitive Map and Statement which relate to the Parish of Wortham in the District of Mid Suffolk have been modified under the said Act and it appears expedient to the County Council to prepare a copy of the Map and Statement as so modified

NOW it is hereby witnessed that in pursuance of the powers contained in Section 57(3) of the said Act:

1. This Statement is the Definitive Statement for the highways shown on the Definitive Map for the area marked thereon as being the Parish of Wortham
2. The relevant date of this Statement shall be 3 April 1987.
